

Liability Waiver and Gas Surcharge Agreement for VanPro Detailing Customers

I, _____, hereby agree to the following terms and conditions before booking a mobile detailing job with VanPro Detailing:

- 1. Acknowledgment of Risks:** I understand and acknowledge that mobile detailing services involve inherent risks, including but not limited to the risk of damage to my vehicle's surfaces or interior due to pre-existing conditions, environmental factors, or unforeseen circumstances during the detailing process.
- 2. Release of Liability:** In consideration for the services provided by VanPro Detailing, I hereby release and forever discharge VanPro Detailing, its owners, employees, agents, and representatives from any and all liabilities, claims, demands, actions, or causes of action that I, my heirs, executors, administrators, or assigns may have for any personal injury, property damage, or other loss sustained as a result of the mobile detailing services, except where such liability arises from the gross negligence or willful misconduct of VanPro Detailing.
- 3. Assumption of Risks:** I voluntarily assume all risks associated with the mobile detailing services provided by VanPro Detailing, including risks that may arise from the use of cleaning products, equipment, and tools.
- 4. Vehicle Condition:** I acknowledge that it is my responsibility to inform VanPro Detailing of any pre-existing damage, defects, or special conditions related to my vehicle prior to the commencement of the detailing service.
- 5. Authorization:** I authorize VanPro Detailing and its employees or agents to perform mobile detailing services on my vehicle as agreed upon, and I agree to provide access to my vehicle at the scheduled time and location.
- 6. Gas Surcharge Agreement:** I agree to a gas surcharge to cover travel expenses incurred by VanPro Detailing for travel to my residence or preferred location for the mobile detailing job. This surcharge will be added to the total cost of the service after the distance has been completed and calculated.
- 7. Full Disclosure:** I confirm that all information provided to VanPro Detailing regarding my vehicle is accurate and complete to the best of my knowledge.
- 8. Indemnification:** I agree to indemnify and hold harmless VanPro Detailing, its owners, employees, agents, and representatives from any claims or actions arising out of or related to my failure to disclose accurate information about my vehicle or from any breach of this waiver.
- 9. Governing Law:** This waiver shall be governed by and construed in accordance with the laws of the province of British Columbia.
